

Ordinary Legislative Procedure



Reasons for the EC proposal

Generally speaking current TMs have several problems

- **\bigstar** Too many regulations \rightarrow > 30 in the framework of the CFP
- Regulatory structure for technical measures highly complex and disjointed
- Current TM «largely not delivered» on the objectives on the conservation and sustainable exploitation of fisheries resources of the previous CFP (Reg. 2371/2002)
- General perception: complex and ineffective rules; inflexible governance structure

Retrospective study in support of the development of a new TM framework within a reformed CFP (MRAG 2014)

NEW TM SCHEME General Provisions

General Provisions – Art. 1-6

Scope

- > Overarching and objectives
- ➤ Targets → expressed in terms of levels of unwanted catches (5%vol); thresholds for bycatches of sensitive species; and reduction in the extent of the seabed affected by fishing.(COM proposal definition) see next Slide
- Definition of fishing zones
- Definitions: fishing gears and fishing operations



- **1.** Technical measures shall aim to ensure that:
 - **1.** catches of marine species below the minimum conservation reference size are reduced as far as possible
 - 2. incidental catches of marine mammals, marine reptiles, seabirds and other non-commercially exploited species do not exceed levels provided for in Union legislation
 - 3. the environmental impacts of fishing activities on seabed habitats are in line with point (j) of Article 2(5) of Regulation (EU) No 1380/2013.
- The extent to which progress was made towards those targets shall be reviewed as part of the reporting process set out in Article 31.

Regionalization - Art. 15

For **regional specificities** of the fisheries, the Commission is empowered to adopt delegated acts in accordance with Article 29 of this Regulation **and Article 18 of Regulation (EU) No 1380/2013** in order to **amend**, **supplement**, **repeal or derogate** from the technical measures set out in the **Annexes**, **including when implementing the landing obligation in the context of Article 15(5) and (6) of Regulation (EU) No 1380/2013**. The Commission shall adopt such delegated acts on the basis of a joint recommendation submitted in accordance with Article 18 of Reg1380/2013.

3. Member States having a direct management interest may submit joint recommendations for the first time **not later than 24 months**, and **thereafter 18 months**, after each submission of the report referred to in Article 31(1) of this Regulation.



First report by 31 December 2020 and every three year thereafter

NEW TM scheme Regionalization (art.15-24)

The technical measures adopted by regionalization shall:

- a) aim at achieving the objectives and targets;
- b) aim at achieving the objectives and comply with the conditions set out in other relevant Union acts adopted in the area of the CFP, in particular in the multiannual plans referred to in Articles 9 and 10 of Reg.1380/13
- c) be guided by the principles of good governance set out in Article 3 of Regulation (EU) No 1380/2013;
- d) As a minimum, lead to such benefits for the conservation of marine biological resources that are at least equivalent, in particular in terms of exploitation patterns and the level of protection provided for sensitive species and habitats, to the measures referred to in paragraph 1. The potential impact of fishing activities on the marine ecosystem shall also be taken into account.

Now we wonder, as 2 years ago: Does the regulation on TM meet with shared objectives?

To answer we need to read the regulation aiming the attention on measures for Mediterranean basin

Reg. 1967/06 and TM regulation differencies Subject matter

Reg. 1967/06

Article 1: Scope

This Regulation shall apply:

- (a) to the conservation, management and exploitation of living aquatic resources where such activities are pursued (i) in the maritime waters of the Mediterranean Sea to the east of the line 5°36' W falling under the sovereignty or jurisdiction of Member States; (ii) by Community fishing vessels in the Mediterranean Sea outside the waters referred to in (i); (iii) by nationals of Member States, without prejudice to the primary responsibility of the flag State, in the Mediterranean Sea, outside the waters referred to in (i); and
- (b) (b) to marketing of fishery products caught in the Mediterranean Sea.

This Regulation shall not apply to fishing operations conducted solely for the purpose of scientific investigations, which are carried out with the permission and under the authority of the Member State or Member States concerned.

New TM Regulation

Article 1: Subject matter

This Regulation lays down technical measures concerning:

(a) the taking and landing of marine biological resources;

(b) the operation of fishing gear;

(c) the interaction of fishing activities with marine ecosystems.

High grading and slipping : NOT IN THE FINAL REGULATION

Article 16

Prohibition of high grading and slipping

1. The practices of high grading and slipping shall be prohibited.

2. Paragraph 1 shall not apply to catches of species which are exempted from the application of the landing obligation in accordance with Article 15(4) of Regulation (EU) No 1380/2013.

Art. 15.4 of Reg. 1380/13:

[(a) species in respect of which fishing is prohibited and which are identified as such in a Union legal act adopted in the area of the CFP;

(b) species for which scientific evidence demonstrates high survival rates, taking into account the characteristics of the gear, of the fishing practices and of the ecosystem;

(c) catches falling under de minimis exemptions;

(d) fish which shows damage caused by predators].

Today fishing for fry of small pelagic stocks is prohibited with all fishing gears only in Adriatic in GSA 17 and GSA 18. (From GFCM 2013/37/1 Rec.)

1. Baseline mesh sizes for towed gear

The following mesh sizes shall apply in the Mediterranean Sea.

¹ It shall be prohibited to use netting with a twine thickness greater than 3 mm or with multiple twines; or netting with a twine thickness of greater than 6 mm in any part of a bottom trawl.

² Only one type of net (either 40 mm square mesh or 50 mm diamond mesh) is allowed to be kept on board or deployed.

What in Reg. 1967/06?

Art.9.4.

For trawl nets targeting sardine and anchovy, where these species account for at least 80 % of the catch in live weight after sorting, the minimum mesh size shall be 20 mm.

Art. 9.5.

For surrounding nets the minimum mesh size shall be 14 mm.

TM Regulation

Art.6.1(3): 'directed fishing' means fishing effort targeted at a specific species or group of species and may be further specified at regional level in delegated acts adopted pursuant to Article 27(7) of this Regulation.

Art.27.7: The Commission is empowered to adopt delegated acts pursuant to Article 15 and in accordance with Article 29 in order to further define the term 'directed fishing' for relevant species in Part B of Annexes V to X and Part A of Annex XI. For this purpose, Member States having a direct management interest in the fisheries concerned shall submit any joint recommendations for the first time not later than ... [12 months after the date of entry into force of this Regulation].

Requirements relating to the characteristics of fishing gear

4. Bottom-set longline

1.Prohibited to have on board or set more than **1 000 hooks/person** on board within the overall limit of 5 000 hooks/vessel.

2.<u>Derogation</u> : each vessel undertaking fishing trips longer than three days may have on board a maximum number of 7 000 hook

6. Surface-set longline (floating)

It shall be prohibited to have on board or set more than:

1. 2 000 hooks/vessel targeting bluefin tuna (Thunnus thynnus);

2. 3 500 hooks/vessel targeting swordfish (Xyphias gladius);

3. 5 000 hooks/vessels targeting albacore (Thunnus alalunga)

where these species account for at least 70 % of the catch in live weight after sorting.

4. D<u>erogation:</u> each vessel undertaking fishing trips longer than two days may have on board an equivalent number of spare hooks.

TM Proposal

Annex IX - Part C

4. Restrictions on the use of longlines

4.1. It shall be prohibited for vessels fishing with bottom-set longlines to have on board or deploy more than 5000 hooks except for vessels undertaking fishing trips of more than 3 days which may have on board or deploy no more than 7000 hooks.

4.2. It shall be prohibited for vessels fishing with surface-set longlines to have on board or deploy more than the number of hooks per vessel as follows:

(a) **2 500** hooks when directed fishing for *swordfish; and*

(b) 5 000 hooks when directed fishing for albacore tuna.

4.3. A vessel undertaking fishing trips longer than 2 days may have on board an equivalent number of spare hooks.

ANNEX XIII

Mitigation measures to reduce incidental catches of sensitive species

Part A Cetaceans

2. Fisheries to be monitored

2.1. Monitoring schemes shall be undertaken on an annual basis and established for vessels flying their flag and with an overall length of 15 m or more to monitor cetacean by-catch, for the fisheries and under the conditions defined below.

→ For Mediterranean Sea: Pelagic trawls (single and pair)

Part B Seabirds

Where the data referred to in point 2 of Part A indicate a level of incidental catches of seabirds in specific fisheries which constitutes a serious threat to the conservation status of those seabirds, Member States shall use bird scaring lines and/or weighted lines, if it is scientifically proven that such use has a conservation benefit in that area, and where practical and beneficial shall set longlines during the hours of darkness with the minimum of deck lighting necessary for safety.
