Subject: New Technical Measures Regulation - recreational fishing

Dear Marina Argyrou, chair of the Sudestmed Member States Group,

The new Technical Measures Regulation (Regulation (EU) 2019/1241¹) was published in the Official Journal of 25 July 2019 and entered into force on 14 August 2019. With this letter, I would like to draw your attention to some of the provisions in this new regulation and in particular on their applicability with regard to recreational fishing.

Recreational fisheries can have a significant impact on fish resources and Member States shall, therefore, ensure that they are conducted in a manner that is compatible with the objectives of the Common Fisheries Policy² (CFP, recital 3). Various measures relating to recreational fisheries are already foreseen in several EU legislative acts and continue to apply together with the measures specifically foreseen in the new Technical Measures Regulation.

Existing standards applying to recreational fishing should not be lowered. Indeed, the new Technical Measures Regulation foresees that "Where relevant, technical measures should apply to recreational fishing, which can have a significant impact on the stocks of fish and shellfish species" (recital 6).

According to Article 2(2) of that Regulation, the following provisions shall also apply to recreational fishing: Article 7 (Prohibited fishing gear and methods), Article 10 (Prohibited fish and shellfish species), Article 11 (Catches of marine mammals, seabirds and marine reptiles) and Article 12 (Protection for sensitive habitats including vulnerable marine ecosystems).

In addition, Article 2(2) stipulates that in cases where recreational fishing has a significant impact in a particular region, the Commission has the power to adopt

Moreover, and without prejudice to its other prerogatives, the Commission remains committed to taking into account of the impact of recreational fishing on fish resources in its annual proposals on fishing opportunities, in the context of emergency measures or in implementing multiannual plans. Finally, Member States may provide in their national legislation for stricter measures concerning recreational fisheries on the basis of Article 19 or 20 of the CFP Regulation, as to ensure these fisheries are conducted in a matter compatible with the objectives of the CFP.
