## WG1: Implementing the landing obligation in 2019

This session will review the concrete practical measures up to date that Member States and other stakeholders have put in place to accompany the full implementation of the landing obligation (e.g. selectivity and avoidance measures, multi-annual by-catch reduction plans).

# WG2: Remote Electronic Monitoring systems for the control of the landing obligation

The effective control and enforcement of the landing obligation at sea is of paramount importance and presents a set of challenges for Member States that have proven difficult by conventional means of control. In order to address this deficiency, the Commission included a legal basis for the mandatory risk based use of Closed-Circuit Television systems, on board vessels, in the new Control Regulation proposal.

This session will focus mainly on the use of Remote Electronic Monitoring (REM) systems and on the progress to date. Selected stakeholders will present their experience on the use of REM to control the landing obligation and other purposes such as the collection of scientific data. Furthermore, the European Fisheries Control Agency will introduce their recently finalised technical guidelines on the use of REM to control the landing obligation and present landing obligation compliance indicators in key fisheries.
